

Guidelines on the Prevention of COVID-19

The health and safety of everyone involved is our highest priority, and Informa Markets is committed to ensuring that all measures – including protocols in line with the HK Government and HKCEC requirements and guidelines – are in place to provide you with an event experience where you can conduct business safely.

With your cooperation and support, we are confident that you will have the most productive show. Read to find out how you can help keep the event and community safe.



LeaveHomeSafe

Before entering the show entrance and designated tasting / catering areas, Trade Buyers are required to either **a) scan the "LeaveHomeSafe" QR code**, and display it to the entrance staff **or b) register contact details** (names, contact numbers and the dates and times of visits) and hand it in to our entrance staff. The Organiser will keep the written or electronic registration records for 31 days.



Body Temperature Check

All individuals are required to undergo an infrared temperature check before entering the HKCEC. Anyone with a high temperature (at or over 37°C) will be denied entry. Trade Buyers who feel unwell or display any COVID-19-like symptoms such as fever ($\geq 37^{\circ}\text{C}$), cough, sore throat or shortness of breath are recommended to seek medical advice immediately and stay home. The Organiser and the venue operator shall have the right to refuse access to any person displaying such symptom(s).



Wear Face Mask

Face masks must be worn in all areas inside the venue (except consuming food or beverages at designated areas). As advised by the Centre for Health Protection (CHP), it is recommended to wear surgical masks.



Cleaning & Sanitising

Hand sanitising stations are located throughout the venue. Buyers are advised to perform hand hygiene frequently, especially if touching the mouth, nose or eyes.



Designated Catering & Tasting Areas

Food or beverage consumption will only be allowed in Cafeteria in Hall 5D. Food and drinks sampling will only be allowed in Designated Tasting Areas.



Eating or drinking is prohibited inside exhibition stands or on hall aisles.

Trade Buyers must sanitise hands before and after receiving food and drinks samples from the exhibitors. All food and drinks samples from exhibitors must be consumed at the designated tasting / catering areas inside the hall. The Organiser and security officers have the right to require buyers to comply with this regulation, and buyers are obligated to follow with our instructions.



Hall Capacity

In cooperation with the HK Government, the venue has adjusted the maximum capacity to avoid overcrowding. The Organiser may take relevant measures such as temporarily suspending registration or entries into the halls to comply with the maximum hall capacity. Please follow the instructions of our staff.



Social Distancing

Trade Buyers should stand at least 1.5m apart while waiting in the queue, in the stand area, on hall aisles and in other areas of the venue. The Organiser and security officers have the right to require buyers to comply with this regulation, and buyers are obligated to follow with our instructions.



Be Considerate

Trade Buyers whose family members or friends have contracted COVID-19 should not visit the exhibition. The Organiser has the right to refuse entry to individuals wearing mandatory quarantine bands.



Emergencies

If an individual who has contracted COVID-19 is found to have visited the exhibition, or if trade buyers or other show personnel have been confirmed to have contracted COVID-19, the Organiser will immediately contact the Centre for Health Protection (CHP) and take appropriate preventive measures in accordance with CHP's guidelines.

Qualified first-aid staff stationed at an isolated room will handle persons displaying COVID-19 symptoms or experiencing discomfort from respiratory infections in accordance with proper procedures.
